# **Letter from your Board President**

It has been a busy few months for your board. Maintenance has been repairing water fountains, walls, and general upkeep of our community.

You have probably noticed the NO PARKING signs along Swan Road. These signs have dramatically reduced semi-truck parking, along with the presence of TPD. Remember, homeowners are welcome to contact Tucson Detective John Gonzales at John.gonzales@tucsonaz.gov with any safety or crime issues.

We have met with the ADOT regarding the Swan Road improvement. Currently, there is a shortfall in the city budget, but hopefully, funds will be available for 2020-21. The board is committed to installing a bench and plaque in memory of Michael Hartman, who was killed while skateboarding, however, this cannot be done until Swan Road is improved. Some obstacles to achieving this include drainage, landscaping (removing or relocating vegetation) and complying with ADA (Americans With Disabilities Act) regulations for the safety and ease of access to disabled homeowners, especially at the intersection of Swan and Valencia where the area narrows considerably.

A new, larger ramada has been approved by the board for Fairy Duster Park. More details to follow. Plans are also in the works for a dog park. Several locations are being considered. A junior sized basketball hoop is being installed and new backboards are being installed on existing hoops. Larger trash bins have been added to Fairy Duster Park, along with signs asking homeowners to take excess trash home if it doesn't all fit into the bins. Help keep our community neat!

# Paint Maintenance

From time to time, you may notice that your home and/or exterior fixtures are in need of stucco/wooden repairs or repainting. You may receive a notice from the Association asking that you assess the exterior condition of your property and make the necessary arrangements to bring the appearance of the home back into compliance. It is important that your homes appearance remain in good condition to maintain the property values throughout the Community.

Should you receive a notice asking for you to repair and/or repaint, it will come with an expected compliance date. If you are altering the exterior of your home in anyway it will need to be submitted to the Committee for review.

If you are planning on color matching with the current paint, as long as there is a successful professional match then a submittal is not necessary. However, for record keeping it is still recommended that you reach out to us in writing with the colors that your home was matched to.
