## **Community Maintenance**

First and foremost, thank you for all those that are in compliance throughout the Community. Your association greatly appreciates all of the time and efforts spent making Rancho Valencia a beautiful Community that so many people love to call home. With that being said, here are some compliance reminders:

- Please pay attention to your front/side yards and curb strip areas, ensuring that weeds are removed. Maintenance is very important during monsoon season, as the weeds can quickly get out of control.
- Dead vegetation should be removed or trimmed of dead portions.
- Desert Broom (bright green weed-like) plants should be removed promptly and while young. Waiting too long may result in difficult removal and prolonged damage to desired vegetation.
- Please be sure that all bushes/shrubs and trees are not encroaching upon the sidewalk, keeping a clear walking path for pedestrians.
- All trees should provide a distinct canopy and should be free of suckers (lower saplings) at or around the base. Canopies should be at least 8' above the sidewalk and driveway.
